Our Voices Matter

Where It All Begins By Linda Ketterer

Margarita Holguin

Making a
Difference
in The Children's
System of Care

I first met Margarita Holguin when I began working as a "Promotora," a Latin American term for Peer Staff. Better known in the Children's System of Care as "Family Youth Partner," it was from Margarita I learned what it means to be a strong community ally. When it comes to community resources, "Promotoras" not only know the community in which they live, but have a deep understanding of community needs in all its diverse aspects. Just because you live in a place, it does not mean you are aware of late night incidents. Promotoras know what happens around the community, in schools, at parks, and on the street.

Margarita describes the Promotoras work as a "bridge" that connects families and service providers in a true and meaningful way, and not just through a flyer or email invitation. Promotoras can function as a "bridge" because they are true peers and personally relate to specific populations, i.e. single parents, uninsured or mental health conditions. Promotora's first build a relationship in order to establish trust so that families can then engage with available resources. Margarita shares that one of the best things about Promotoras is their ability to build culturally sensitive trust by using their



lived experience which help families engage, heal, and thrive.

Margarita worked for Health and Human Services for over 20 years and now is the Executive Director of the Chula Vista Community Collaborative, where she has served for the past ten years. This organization oversees a network of five Family Resource Centers offering family support, advocacy, parenting resources, support, health insurance enrollment, employment resources, and adult education, among other services.

Promotoras help engage families in the public sector, promoting resources at health fairs and within the community. They help in the private sector, by encouraging families to engage in services that are within the Children's System of Care. Promotoras are also strong leaders in the education sector, participating with schools and community activities.

A unique challenge Margarita finds is providing appropriate staff support for the Promotora. As "Peer Staff" with lived experience, Promotoras have been in similar situations as the families they serve. Because of this, Margarita understands that to keep a healthy, vibrant pool of Promotoras, supervisors and agencies alike must to find ways to provide effective support to Promotoras.

As we reflect on the past 12 months, we take in the first full year of Liaison activities. We brought CSOC information on resources and Issue Resolution to more than 5,500 community and family members. We supported 39 "Ending the Silence" (ETS) impactful presentations where a young adult shared their personal lived experiences of a mental illness at 14 County High Schools reaching 4,688 youth. We provided in-person and on-line trainings to strengthen the working relationship between Family Youth Partners / peer staff with lived experience and Program Staff / mental health



clinicians and professionals, by training over 125 staff within the CSOC. We launched a monthly peer support group for parents of minor children with behavioral health concerns. We began offering "NAMI Basics," a free, six-week, 15-hour education series for parents and caregivers of minors and TAY with behavioral health concerns. We have increased regional opportunities for families and youth receiving behavioral services to give the CSOC and County feedback as we have increased opportunities to hear the community voice by moving our Family Youth Focus Group to a Facebook live conversation platform with youth, parents and members of the CSOC. We invite all to join us on Facebook Live September 5, 2017 at 2 pm. We are looking forward to bringing more strength and impactful programs to the Children's System of Care in the year ahead.



Issue Resolution



The NAMI San Diego Children Youth & Family Liaison (CYFL) serves as the Mental Health Services Act (MHSA) Resolution Point-of-Contact for issues within the Child Youth & Family Behavioral Health Ser-

vices System of Care (CYFBHSOC). We serve the community by facilitating dialogue between families, Family Youth Partners, and providers. Families can attend our Family Voice Meetings to talk about what is working well for them and where they need additional support within the Children's System of Care. If families feel they are not receiving proper care from their providers, have an issue, or if they are struggling to find the services they need, the CYF Liaison provides a safe, trauma informed, judgment free space for families to discuss and resolve these concerns and also provides Behavioral Health Services with community feedback to assist in improving the current system of care.
